## Service Agreement Exhibit "B"

**I. PURPOSE:** HARRIS COUNTY MUD 213-A (herein after referred to as the "District") is responsible for protecting the drinking water supply from contamination or pollution, which could result from improper plumbing practices. The purpose of this Service Agreement is to notify each customer of the plumbing restrictions, which are in place to provide this protection. The District enforces these restrictions to ensure the public health and welfare. Each customer must sign this agreement before the District will begin service. In addition, when service to an existing connection has been suspended or terminated, the District will not re-establish service unless it has a signed copy of this Service Agreement.

- II. PLUMBING RESTRICTIONS:** The following unacceptable plumbing practices are prohibited by State Regulations.
- a. No direct connection between the public drinking water supply and a potential source of contamination is permitted. Potential sources of contamination shall be isolated from the public water system by an air-gap, or an appropriate backflow prevention device in accordance with state plumbing regulations. Additionally, all pressure release valves and thermal expansion devices shall be in compliance with state plumbing codes.
  - b. No cross-connection between the public drinking water supply and a private water system is permitted. These potential threats to the public drinking water supply are not permitted.
  - c. No connection, which allows water to be returned to the public drinking water supply, is permitted.
  - d. No pipe or pipe fitting installed on or after January 4, 2014, which contains more than 0.25% lead may be used for the installation or repair of plumbing at any connection which provides water for human use.
  - e. No solder or flux, which contains more than 0.2% lead, can be used for the installation or repair of plumbing at any connection on or after July 1, 1988, which provides water for human use.
  - f. No plumbing fixture shall be installed which is not in compliance with a state approved plumbing code.

- III. SERVICE AGREEMENT:** The following are the terms of the service agreement between the District and \_\_\_\_\_ (the Customer).
- a. The District will maintain a copy of this agreement as long as the Customer and/or the premises is connected to the District's water system.
  - b. The Customer shall allow his property to be inspected for possible cross-connections and other unacceptable plumbing practices. These inspections shall be conducted during the District's normal business hours.
  - c. The District shall notify the Customer in writing of any cross-connection or other unacceptable plumbing practice which has been identified during the initial inspection or the periodic re-inspection.
  - d. The customer shall immediately correct any unacceptable plumbing practice on his/her premises.
  - e. The customer shall, at his/her expense, properly install, test, and maintain any backflow prevention device required by the District. Copies of all testing and maintenance records shall be provided to the District.

**IV. ENFORCEMENT:** If the customer fails to comply with the terms of this Service Agreement, the District shall, at its option either terminates service or properly install, test, and maintain an appropriate backflow prevention device at the service connection. Any expenses associated with the enforcement of this Service Agreement shall be billed to the Customer.

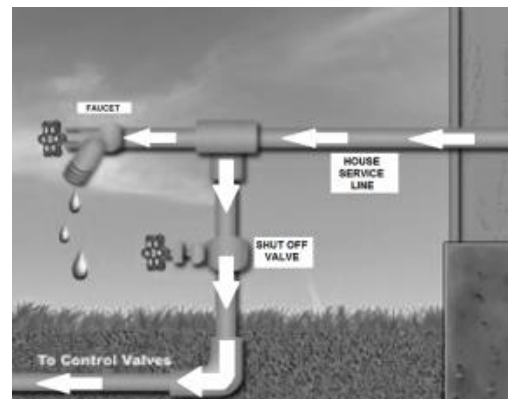
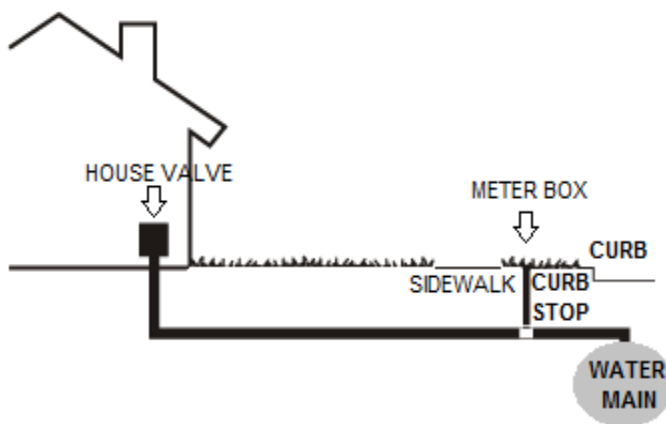

### *Service & Collection Guidelines*

---

#### ***Service Days and Hours***

---

**Trash:** Tuesday & Friday

Please have waste curbside by 7:00 am. Service hours may change with new provider.

---

#### **Carts**

---

Texas Pride Disposal will provide each household with one 65-gallon trash cart.

Cart requests can be made by calling 281-342-8178 or emailing

service@texaspridedisposal.com. Carts

are not required for service. Place waste curbside in bags or cans while awaiting delivery.

---

#### **Holiday Schedule**

---

Texas pride Disposal observes three holidays: New Year's Day, Thanksgiving Day, and Christmas Day. In the event that your service day falls on a holiday, collection will roll to the next regularly scheduled collection day.

---

#### **Household Trash**

---

Waste should be placed in the provided cart, personal cans between 20 and 96 gallons and under 50 pounds, or sturdy bags not exceeding 50 pounds. Waste should be placed curbside.

---

#### **Yard Waste**

---

Yard waste should be bagged or placed in cans not exceeding 50 pounds. Bagged yard waste should be placed curbside. Branches should be placed curbside in bundles measuring no more than 4' x 4' x 4' and under 50 pounds. Limit 8 bundles per service day.

---

#### **Heavy Trash & Bulk Waste**

---

Texas pride Disposal will collect two heavy trash/bulk items per service day. Items include furniture, appliances, carpeting (tied and bundled), fencing (nails removed, tied and bundled under 4' in length), and other items not disposed of regularly.

Items should be curbside.

---

#### **Items Excluded from Regular Collection**

---

The following items cannot be collected: dirt, rocks, brick, concrete, liquid paints, fuels, oils, tires, pesticides, fertilizer, and batteries. Please contact us to discuss solutions for proper disposal of these items.
